## Important Notice about your Medication Coverage

Dear Sheet Metal Workers' Local 46 Participant,

As of March 27, 2016, NYS Public Health Law requires your provider to electronically prescribe (**Escribe**) your prescription medications directly to your pharmacy. Under most circumstances, prescriptions will no longer be handwritten or phoned into your pharmacy.

This is an important opportunity for anyone using maintenance medications to utilize their union benefit and realize direct cost-savings. Maintenance medications are those prescriptions that are taken on a regular basis to treat conditions such as cholesterol, blood pressure, or diabetes. Your plan allows the physician to prescribe a 90-day or 3-month supply when treating these types of conditions, which can be provided to you by Envision Pharmacies (formerly known as Orchard Pharmacy).

EnvisionPharmacies is your mail-order pharmacy and can provide your medication(s) to you at a reduced cost. By using this benefit, you will receive a significant cost-savings to you, and also to your union health fund.
