**SUMMARY PLAN DESCRIPTION**

**AMENDMENT**

Pursuant to Section 24 of Article V of the Restated Agreement and Declaration of Trust of the Sheet Metal Workers Local Union No. 46 Health Fund, the Fund's Summary Plan Description is amended as follows:

I.

The Subsection titled "**Retail Pharmacy Program**" in the Section titled "**Prescription Drug Benefits (For Active Participants And Dependents)**" is amended by adding the following paragraph to the end of the Subsection:

***Retail Pharmacy Vaccination Program***

The following vaccinations administered at participating pharmacies are covered under the Plan, subject in certain cases to age restrictions:

<b>Group</b>	<b>Vaccine</b>
Flu (seasonal influenza)	Influenza (trivalent, quadrivalent, cell-based, preservative free, intradermal, high dose, etc.)
Hepatitis	Hepatitis A Virus Hepatitis B Virus Hepatitis B Virus, Hepatitis A Virus
Pneumonia	Pneumococcal
Shingles	Zoster-Shingles
HPV	Human Papillomavirus
Childhood Vaccines	Measles, Mumps & Rubella (MMR) Measles, Mumps, Rubella, Varicella Varicella Haemophilus influenzae B (combo) Poliomyelitis
Meningitis	Meningococcal

Group	Vaccine
Tetanus/Diphtheria/Pertussis	Tetanus Booster DT, DTaP, Td, Tdap, TT (+ other combos)
Travel Vaccines	Japanese Encephalitis Typhoid Yellow Fever BCG Rabies Anthrax

II.

The Section titled “**Prescription Drug Benefits (For Active Participants And Dependents)**” is amended by revising Exclusion 4 in the Subsection titled “**Expenses Not Covered**” (page 57) as follows, with revised language in bold italics:

4. Drugs administered to an eligible person by the prescriber in his or her office. ***(This exclusion does not apply to vaccinations covered under the Retail Pharmacy Vaccination Program.)***

III.

Exclusion 10 in the Section titled “**General Plan Exclusions**” (page 81) is revised as follows, with new language in bold italics:

10. Expenses for services not prescribed by a licensed physician, unless explicitly authorized by other provisions of this Plan. ***(This exclusion does not apply to vaccinations covered under the Retail Pharmacy Vaccination Program.)***
